

# CHAPTER 9: RR – RURAL RESIDENCE DISTRICT

## 9.01 Purpose

The regulations set forth in this chapter are to encourage the development of low density single family dwellings on large lots to preserve open space.

## VILLAGE OF MAINEVILLE ZONING ORDINANCE

---

~~(A) Residential: Any use permitted in the Residential District R-1.~~

~~(B) Recreational Uses: Recreation area, private or charitable, provided a minimum of thirty (30) acres is used and fenced on all sides.~~

~~(C) Agricultural Uses:~~

~~(1) The keeping of animals as pets exclusive of swine and poultry, provided however, that any shelter for ponies, horses, sheep, or goats, shall be at least one hundred (100) feet from every inhabited dwelling house.~~

~~(2) Outdoor houses for not more than two (2) adult dogs and/or cats are permitted but must be located in the rear yard, but at minimum of (10) feet from each property line.~~

~~(3) Out door housing for more than three (3) adult dogs and/or cats shall be considered a private kennel and fencing will be required at a minimum of twenty five (25) feet from each property line.~~

~~(a) Kennel sizes shall be ten (10) feet long, four (4) feet wide and five (5) feet high, minimum per animal, and the floor shall be made of concrete. County license and zoning permit must first be obtained before a kennel will be permitted.~~

~~(4) Private Stables only no beast or space for hire.~~

~~(D) Roadside stands:~~

~~(1) Roadside stands shall only be permitted for the sale of products grown on the premises.~~

~~(2) Roadside stands shall be set back a minimum of fifteen (15) feet from the road right of way.~~

~~(3) Roadside stands shall not exceed one hundred (100) square feet in floor area.~~

~~(E) Farming Uses: Horticultural, floricultural and other agricultural related uses and services.~~

~~(F) Nature: Natural and wildlife preserve sanctuaries.~~

~~(G) Retail: Garden store, nursery and similar landscape sales of products produced on the premises.~~

~~(H) Places of Worship: Churches, synagogues, temples and other places of religious assembly for worship.~~

~~(I) Bed and Breakfast: See Chapter 24, Other Use Specific Regulations.~~

~~(A) **Cemeteries:** Provided any mausoleum therein, shall be at least two hundred (200) feet from every property line and provided further that any cemetery shall contain an area of twenty (20) acres or more.~~

~~(C) **Public and Institutional Uses:** Fire House, Police Station, and Government Offices, parks, playgrounds and community centers.~~
